- 2) Set - up should be completed no later than 11:30 AM and ALL vehicles parked in designated location.
- 3) Vendor booths must be set - up for the entire event time. You will not be allowed to drive your vehicle to your space for break - down until.
- 4) Displays/Spaces must be manned at all times during event hours
- 3) Each participant is responsible for collecting and submitting sales tax to the Florida Department of Revenue.
- 5) Vendors/Organizations are required to handle their own clean - up. Remove all trash to the appropriate disposal areas at the venue.
- 6) All dogs/animals brought by rescues, shelters, and vendors must be spayed/neutered and current on all shots/vaccinations.
- 7) No animal should be left unattended and should be handled by a responsible adult and on lead at all times.
- 8) No loud generators.
- 9) No refunds due to inclement weather. There is no rain date.
- 10) All fees, payments, donations, etc are non-refundable.
- 11) Non - profit organizations must submit a 501c3 proof of status and liability insurance proof with application.
- 12) Spaces are limited and will be accepted on a first come, first serve basis.
- 13) All vendors agree to and are responsible for abiding by all applicable laws and ordinances.
